**COMUNICADO AO MERCADO**

A **INTERNATIONAL MEAL COMPANY ALIMENTAÇÃO S.A.** (B3: MEAL3) ("Companhia") informa que, nos termos do Art. 12 da Instrução CVM 358/02, recebeu, nesta data, a carta anexa enviada pela British Columbia Investment Management Corporation, inscrita no CNPJ/MF sob o nº 13.926.203/0001-55, com sede à 750 Pandora Ave, Victoria, British Columbia, Canada ("BCI"), comunicando que a BCI, indiretamente por suas subsidiárias, passou a deter 9.782.114 (nove milhões, setecentos e oitenta e dois mil, cento e quatorze) ações ordinárias de emissão da Companhia, correspondentes a 4,99% (quatro vírgula noventa e nove por cento) do capital social da Companhia.

A BCI comunicou ainda (i) que a alienação de ações da Companhia não objetiva alterar a composição do controle acionário ou a estrutura administrativa da Companhia, (ii) que os únicos valores mobiliários detidos pela BCI são as ações indicadas acima, (iii) não detém debêntures ou quaisquer outros valores mobiliários conversíveis em ações emitidas pela Companhia, e (iv) não é parte de qualquer acordo ou contrato regulando o exercício do direito de voto ou a compra e venda de valores mobiliários de emissão da Companhia.

**Ref: International Meal Company Holdings S.A. – Shareholding Notification**

1. The undersigned British Columbia Investment Management Corporation (“**BCI**”), hereby informs that, as of 2 December 2019, BCI has decreased its holdings of common shares issued by **International Meal Company Holdings S.A.** (“**Company**”) to 9,782,114 shares (4.9929%).
2. Prior to 2 December 2019, BCI indirectly held 11,127,614 shares (representing approximately 5.49% of the total common shares issued by Company) through its subsidiaries bclMC Private Placement (2007) Investment Corporation and bclMC (WCBAF) Private Placement 2007 Investment Corporation.
3. For the purposes of Article 12 of the Brazilian Securities Commission (“**CVM**”) Instruction 358 dated January 3, 2002, as amended, BCI hereby requests Company’s Investors Relations Officer to disclose the following information to CVM and to other applicable entities:
  - (i) BCI registered office is headquartered at 750 Pandora Ave, Victoria, British Columbia, Canada and is enrolled with the Brazilian Taxpayers’ Registry (*Cadastro Nacional de Pessoas Jurídicas – CNPJ*) under number 13.926.203/0001-55;
  - (ii) the equity interest sold by BCI was of a purely investment/financial nature and the transaction does not have the purpose to either change the Company’s control composition or the Company’s management structure;

- (iii) the only securities of the Company held directly or indirectly by BCI are those indicated in this letter;
- (iv) no convertible debentures nor any other securities convertible into shares issued by the Company are held by BCI; and
- (v) BCI is not a party to any agreement or contract regulating the exercise of voting right or the purchase and sale of securities issued by the Company including that it has no right to exercise voting rights on the common shares it holds indirectly.
