THE **INTERNATIONAL MEAL COMPANY ALIMENTAÇÃO S.A.** (B3: MEAL3) a corporation publicly-held company registered with the Brazilian Securities and Exchange Commission ("<u>CVM</u>") in seniority "A", headquartered in the City of São Paulo, State of São Paulo, at Avenida Doutora Ruth Cardoso, 4.777, 12th floor, suite A, Jardim Universidade Pinheiros, CEP 05477-902 ("<u>Company</u>" or "<u>IMC</u>"), in compliance with the provisions of article 157, paragraph 4 of Law No. 6,404/76, of December 15, 1976, as amended ("<u>Brazilian Corporation Law</u>"), CVM Resolution No. 44, of August 23, 2021 and CVM Resolution No. 78, of March 29, 2022, and in continuation of the relevant fact disclosed on March 26, 2025, to the notice to the market disclosed on April 09, 2025 and to the relevant fact disclosed on May 08, 2025 ("<u>Relevant Facts</u>"), hereby informs its shareholders and the market in general that, on this date, in preparation for the closing of the transaction contemplated in the "*Share Purchase and Investment Agreement*", entered into the Company on March 26, 2025, were approved:

- at the Company's Extraordinary General Meeting, the merger of KSR Master Franchise Ltda. by the Company, pursuant to arts. 223 and 227 of the Corporation Law; and
- (ii) at a Meeting of the Company's Board of Directors, the implementation of the other stages of the Company's corporate reorganization, consisting of (*ii.a*) the contribution, by the Company, to the capital stock of Horizonte Restaurantes S.A. (CNPJ/MF No. 58.891.504/0001-29), a company incorporated for the sole purpose of this purpose ("<u>Horizonte</u>"), of the assets currently held by KSR and which were transferred to the Company through the Merger, and others currently owned by the Company on the date ("<u>Drop Down</u>"), and also (*ii.b*) the contribution, by Pimenta Verde

Alimentos Ltda. (CNPJ/MF No. 09.060.964/0001-08), a company whose capital is wholly owned by the Company ("<u>Pimenta Verde</u>"), to the capital stock of Horizonte, of certain assets currently held by Pimenta Verde in order to segregate for Horizonte the assets necessary for the development of KFC Activities (as defined in the Relevant Facts).

The Company will keep its shareholders and the market in general informed of any relevant updates compliance with the matters reported herein and in the Relevant Fact.
