Furthermore, according to the correspondence received, which is attached hereto and forms an integral part of this notice, the stated purpose of the aforementioned shareholding is strictly for investment purposes, in accordance with the investment policy of the funds under its management, with no intention to alter the Company's control structure or management.

Brigadeiro Faria Lima, 2601, suite 102, Jardim Paulistano, São Paulo/SP, CEP: 01452-924 (“**UV Gestora**”), hereby informs the market in general, pursuant to Article 12 of the Resolution of the Brazilian Securities and Exchange Commission – RCVN No. 44/2021, that as of this date, the investment funds under its discretionary management and legally represented by UV Gestora (“**UV Funds**”), have reached a shareholding participation of 35.01% of the total and voting share capital of INTERNATIONAL MEAL COMPANY ALIMENTAÇÃO S.A. (“**Company**”).

As of the present date, the UV Funds hold 100,358,160 common (ON) shares issued by the Company. The UV Funds do not, as of this date, directly or indirectly, hold any other securities issued by the Company or derivative instruments referenced to such securities.

UV Gestora further informs that: (i) it does not intend to alter the Company’s control structure or management, nor to exercise influence over its financial or operational policies; (ii) it has not entered into, nor is it a party to, any agreement or contract governing the exercise of voting rights or the purchase and sale of securities issued by the Company. The investment is strictly financial in nature and is made in accordance with the investment policy of the UV Funds.

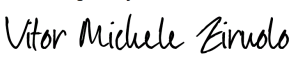

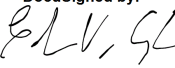
